

## Entry requirements for degree programmes at Accademia Tiepolo

### Foreign study qualification

The procedure to enrol in a Bachelor's Degree Programme (three years), for students holding a foreign study qualification differs depending on whether the student is a:

- non-EU citizen resident abroad
- EU citizen or non-EU citizen resident in Italy

These procedures are subject to current and future emergency provisions by the Italian Government and European Union to prevent and curb Covid-19 virus epidemic.

1. First, you need to fill out the online "**pre-enrolment application**"
2. On the Accademia portal you will find all the information you need to complete the pre-enrolment application.

The deadline is **15 September 2020**.

Documents to upload in PDF format on the Accademia website:

- Final high-school qualification in original copy, obtained after at least 12 years of school, or replacement certificate for all legal purposes, translated and legalised. Further **information on study qualifications deemed valid** is available on (insert link relating to the new year <https://www.studiare-in-italia.it/studentistranieri/moduli/2020/allegato1.pdf> ).
  - Declaration of value of the qualification obtained or COMPARABILITY CERTIFICATE issued by the **Centro di informazione sulla mobilità e le Equivalenze accademiche (CIMEA)** belonging to the ENIC-NARIC networks.   - Certificate stating that you have passed the university proficiency test, if provided to access the University of the country you come from (Selectividad in Spain, Prova de Aferiçao or Prova General de Acesso ao Ensino Superior in Portugal, etc..) or that you have obtained at least the minimum score (e.g. Gaokao for China).
  - Language certificate stating your knowledge of the Italian language (at least B2), if any;
  - Colour photo of your face in foreground
  - Valid passport
3. After completing the pre-enrolment application, the Registrar's Office will evaluate the documents you uploaded on the Accademia website and will send you an email if additional documents are required.
  4. Passing the Italian language test except for exempted students for some degree programmes, the Italian language test may also be taken by remote.
  5. After completing the pre-enrolment application, **all applicants shall request the study/university enrolment visa to the Italian diplomatic consular representation of the country of residence [vistoperitalia.esteri.it](http://vistoperitalia.esteri.it)**  
All procedures for issuing the visa must be completed by **30 November 2020**.

6. The diplomatic representation will load the entry visa on Accademia. Only after obtaining the visa, the Registrar's Office will enrol you and give you all instructions to pay the first instalment of accademia fees. After making the payment, you will be enrolled subject to the delivery of the original study qualification and residence permit documents.
